### **REPORTS:**

**Secretary's Report:** The minutes of the Tripp County 4-H Leaders Corporation meeting of the previous meeting, were sent out through email to be read prior to the meeting. **Treasurers Report:** Treasurer Scott Hollenbeck presented a report as of September 18, 2023
